HOW IT WORKS

1. You can book by telephone, using the booking app or online using e cab call. All booking methods will avoid call queues.
2. You will be asked to provide your account number and a four digit PIN which you create on the attached booking form. You can create unique PIN numbers for each account user
3. You will receive an invoice at the end of each month detailing your journeys. Payment will be collected by Direct ebit from your account on or around the 28th of the following month.
4. At the end of each journey your driver will enter the fare details into the onboard dispatch system, these are transferred to your account details.
5. An administartion charge of 12.5% will be added to the total. VAT is payable on the administration charge.
6. A cancellation charge will apply if a journey is cancelled after a taxi has been dispatched.
7. The minimum charge of an Account hire is currently set at £5.80.
8. There are no geographical charged (boundary charges) applicable to account hires.
